ARRESTED CO-DEFENDANTS

DEFENDANT DID THE FOLLOWING ACT(S) WHICH CONSTITUTE A VIOLATION OF THE LAW (ELEMENTS OF THE CRIME / PROBABLE CAUSE STATEMENT)

ON 05/22/10 AT APPROXIMATELY 2343 HOURS, I WAS DISPATCHED TO 8369 RIMINI WAY, NAPLES, ON A REPORT FROM A FEMALE CALLER ADVISING THAT SHE HAD BEEN INVOLVED IN A PHYSICAL CONFRONTATION WITH HER HUSBAND, NICK LICHTER. THE CALL COMMENTS ADVISED THAT NICK WAS INTOXICATED AND TRASHED THE HOUSE. THE CALL COMMENTS WENT ON TO ADVISE THAT NICK THREW THE CALLER AGAINST THE WALL AND THAT THERE IS A HISTORY OF ABUSE. ULTIMATELY, THE CALL COMMENTS ADVISED THAT NICK HAD LEFT THE RESIDENCE ON FOOT, DESTINATION UNKNOWN.

## \*\*\*OBSERVATIONS\*\*\*

I ARRIVED AT THE LOCATION AND MADE CONTACT WITH THE REPORTER, KELLY E. LICHTER (DOB 05/04/79), THE VICTIM, INSIDE HER RESIDENCE. SHE WAS SITTING DOWN ON THE COUCH IN THE LIVING ROOM WITH HER OLDEST CHILD. KELLY WAS NOT CRYING. SHE ACTED CALM. I DID NOT OBSERVE ANY VISIBLE MARKS/INJURIES ON HER PERSON. I DID OBSERVE A BROOM PROPPED UP AGAINST A WALL. I FURTHER OBSERVED SEVERAL PIECES OF BROWN GLASS ON THE FLOOR OF THE LIVING ROOM IN FRONT OF THE MAIN ENTRANCE.

## \*\*\*VICTIM'S STATEMENT\*\*\*

KELLY ADVISED ME THAT HER HUSBAND, NICHOLAS W. LICHTER (DOB 02/04/68), THE DEFENDANT, LEFT THE RESIDENCE AT APPROXIMATELY 1630 HOURS ON 05/22/10 TO ATTEND A MIRACLE BASEBALL GAME IN FT. MYERS WITH HIS FRIENDS. SHE ADVISED THAT SHE WAS SICK AND WAS NOT HAPPY ABOUT NICHOLAS ATTENDING THE GAME WHILE SHE WAS HOME SICK. SHE ADVISED THAT THE WHOLE TIME HE WAS AT THE GAME HE NEVER CALLED ONCE, WHICH MADE HER EVEN MORE ANGRY.

KELLY ADVISED THAT NICHOLAS RETURNED AT APPROXIMATELY 2330 HOURS. SHE ADVISED THAT SHE COULD SMELL ALCOHOL ON HIS BREATH. SHE ADVISED THAT THEY STARTED ARGUING. KELLY ADVISED THAT AT SOME POINT DURING THE ARGUMENT HE LAUGHED AND THAT GOT HER VERY ANGRY AND SO SHE ADVISED HIM THAT SHE WANTED TO DIVORCE HIM. SHE WENT ON TO ADVISE THAT THE STATEMENT SET HIM OFF. SHE ADVISED THAT SHE WAS STANDING BY THE MAIN ENTRANCE WHEN HE THREW A BEER BOTTLE IN HER DIRECTION. SHE ADVISED THE BOTTLE HIT THE MAIN DOOR AND SHATTERED. I DID OBSERVE DAMAGE TO THE DOOR. SHE ADVISED THAT HE DID NOT INTEND TO THROW THE BOTTLE AT HER AND HIT HER.

SHE FURTHER ADVISED THAT HE GRABBED HER FROM THE FRONT BY BOTH SHOULDERS AND PUSHED HER BACK INTO THE WALL. I DID OBSERVE A SMALL RED MARK IN THE AREA OF HER RIGHT SHOULDER BLADE. SHE

DEFENDANT DID THE FOLLOWING ACT(S) WHICH CONSTITUTE A VIOLATION OF THE LAW (ELEMENTS OF THE CRIME / PROBABLE CAUSE STATEMENT)

ALSO ADVISED THAT NICHOLAS THEN PUSHED A CHAIR INTO A LITTLE TABLE STANDING BY THE WALL AND THE IMPACT BETWEEN THE TWO PIECES CAUSED THE LITTLE TABLE TO CONTACT THE WALL, DAMAGING IT. KELLY FINALLY ADVISED THAT WHEN NICHOLAS WAS WALKING OUT OF THE RESIDENCE, HE BROKE THE LAMP WHICH WAS LOCATED ON THE TABLE NEXT TO THE GARAGE DOOR ENTRANCE.

DIGITAL PHOTOS OF THE ABOVEMENTIONED WERE TAKEN AND PLACED INTO EVIDENCE.

\*\*\*DEFENDANT'S STATEMENT\*\*\*

NICHOLAS WAS LOCATED WALKING IN THE AREA OF THE CLUB HOUSE. I READ HIM THE MIRANDA WARNING. HE ADVISED THAT HE WILL ANSWER MY QUESTIONS. HE ADVISED HE CONSUMED THREE BEERS THIS EVENING. HE ADVISED THEY DID ARGUE BUT HE NEVER TOUCHED HER. HE ADVISED THAT HE DID THROW A BEER BOTTLE AT THE DOOR, NOT AT KELLY. HE ALSO ADVISED THAT HE DID PUSH THE CHAIR. HE ADVISED HE DID NOT REMEMBER BREAKING THE LAMP.

KELLY ADVISED ME THAT THERE IS A HISTORY OF UNREPORTED PHYSICAL ABUSE. SHE ADVISED THAT THEY LIVE TOGETHER AND HAVE TWO CHILDREN IN COMMON. SHE ADVISED THE CHILDREN DID NOT WITNESS THE INCIDENT BECAUSE THEY WERE UPSTAIRS.

KELLY COMPLETED A SWORN STATEMENT FORM. SHE WAS PROVIDED WITH THE D.A.R.T. PAMPHLET. SHE SIGNED THE V.I.N.E. FORM REQUESTING TO BE NOTIFIED. D.V. CHECKLIST WAS ALSO COMPLETED.

NICHOLAS WAS TRANSPORTED TO NJC FOR BOOKING WITHOUT FURTHER INCIDENT.
